The primary responsibility of the Registration Committee (RC) is to register members of this Association. This duty is carried out within the terms of the Engineering & Geoscientific Professions Act and in accordance with the policies of Council as laid out in the Association's Manual of Admissions.

This Committee reviews files forwarded from the Academic Review Committee (ARC), the Experience Review Committee (ERC) and Association staff. The members review these files based on the recommendations from the ARC and ERC in keeping with the Manual of Admissions. Final acceptance of the files is made by this Committee and Council duly notified. The Committee also hears appeals against the decisions of the ARC or ERC, as well as registration related issues and provision of recommendations regarding same to the Executive Director and Council.

The Registration Committee, composed as per its terms of reference, meets regularly on the last Wednesday of every month so that files processed by the ARC and ERC can be reviewed in a timely manner. This year 12 regular meetings were held, with no appeal meetings nor special hearings required. During this past fiscal year, the following number of files were reviewed by the Committee:

- 126 MIT's from Assessment, 189 MIT's and 4 MIT from Reinstatement were enrolled.
- 22 Engineers were registered as Licensees No Geoscientists applied for Licensee status.
- 173 Engineers and 8 Geoscientists were registered as new members.
- 336 Engineers and 12 Geoscientists were registered by Mobility.
- 37 Engineers and no Geoscientist applied by Reinstatement Mobility.
- 1 Engineer was registered by Reinstatement. No Geoscientists applied for Reinstatement.

This year, one mobility applicant completed their application for membership by fulfilling an outstanding discipline order in another jurisdiction. No additional action was required by the committee to complete this applicant registration process.

Another mobility applicant was discussed and is tentatively awaiting registration owing to the need to confirm that the fulfillment of a disciplinary order from another jurisdiction is complete. It is not expected that this applicant will require more action by the committee.

The Committee membership has expanded by one over the last year. There had been two resignations from the committee. One was due to employment responsibilities increasing for that member, and the

other owing to the adherence to the term limit for committee members from the terms of reference for the committee. Two current members have reached the maximum time allowance for service in keeping with the committee terms of reference. New members are being brought in gradually so that abrupt changes in committee composition and experience do not occur.

At this time I would like to formally thank M. Kirton, MAA, MRAIC, for his work on our Committee serving as a reviewer from the Architecture profession. I welcome new committee members Alan Baskin, Roland Geria, and Paul Bernatsky. I would also like to thank the remaining Committee members for their commitment to ensuring that a fair, reasonable, and thorough review process is carried out for each applicant. Indeed, they have maintained good consistency from file to file as new committee member's transition from those that have guided the registration committee in the past. Lastly, I'd like to thank (Steven) W. Wu for stepping into the chair role as of the September meeting. I wish him all the best in his upcoming experiences.
