

CALL FOR VOLUNTEERS

Are you interested in volunteering? Want to give back to the professions? Are you in need of hours for ProDev? If so, the Association is looking for professional members to become assessors for the Competency-Based Assessment process.

Competency-Based Assessor

Engineers Geoscientists Manitoba has transitioned to a Competency-Based Assessment (CBA) Reporting System to determine when an applicant has progressed to a professional level of competency in their field to gain licensure. CBA asks applicants to use situational actions to demonstrate their achievements of the required competencies, that are then validated by the applicant's validators who provides feedback and ratings for each competency, commenting on their readiness for professional registration. The assessor then does the final review of the applicant's competencies and provide their own ratings for each competency, then making recommendation on the applicant's readiness for professional registration.

General Duties and Responsibilities:

- Conducted remotely, assessors will review applicant's submissions, as well as validator feedback.
- Assessors provide ratings for each competency and make a recommendation on the applicant's readiness for professional registration.
- These assessments can be done at the time and location of the assessor's choice.
- Online training is provided and is mandatory for all assessors. Staff will be available for questions and will provide further additional training as required.

Specific Skills and Qualifications

- Be currently registered as a practising professional member and be receiving remuneration on a fulltime or regular basis (greater than 300 hours per calendar year) in the practice of professional engineering and/or professional geoscience in your stated field of practice.
- Be reporting full ProDev.
- Have an awareness of current practice standards, employer contexts, and workplace cultures.
- Be in good standing with the Association.
- Those working at a senior level capacity are preferred.
- Be able to commit to reviewing files on a regular basis.

All disciplines are encouraged to apply, but those who are in the following disciplines are the most needed:

- Civil (all subdisciplines, particularly structural, water resources, transportation)
- Mechanical (particularly manufacturing, HVAC, aerospace, metallurgical)
- Electrical (Power distribution, electronics)
- Computer (Software, hardware)
- Geology
- Industrial
- Military

We are hoping for a diverse group of assessors who come from a variety of industries and specialties.



Time Commitment:

- A typical review will take approximately one to two hours of documentation review at first (45 minutes to one hour when you are familiarized with the Competency Assessment Reporting System).
- The number of reviews requested of you will depend on the number of applications submitted related to your field of expertise.
- There are no set meetings for this work, assessors are to review the assessments at the time and location of their choice ideally within one month of being assigned the assessment. This is flexible depending on the number and complexity of the files assigned.
